A New Deal in U. of I. Rushing
SPRING PLEDGING WEEK-END TO BE HELD
WEEK-END OF MAY 15 to 17 AT ILLINOIS

This year formal rush will be held at Illinois the week-end of May 15 to 17 and at this time U. of I. fraternities are expected to pledge most of the men they will need to fill their houses next fall. However, only 300 men are signed up for this new early week-end as compared with the 800-1000 usually going thru fall rush. There will be no fall rush as such this year, so we will probably have to fill some of our quota of pledges this summer during the period of "Wildcat Rushing". Under this system of "Wildcat Rushing" any member of the house is able to pledge a prospective rushee on the spot.

This new program indicates that every alumnus must be on the lookout for good Alpha Chi Rho membership prospects. In addition, those alumni will have to contact young men entering the University of Illinois and not only sell the Fraternity System, but specially on the virtues of ALPHA CHI RHO. Alumni will have to send names of these men planning to attend the University of Illinois to our rush chairman so members of the house can contact them as soon as possible. Remember these facts:

- 1. Freshmen now being given permits to enter next fall (and thus are eligible for rushing) are to the top scholars—in the upper quarter of their graduating class.
- 2. As they are given permits to enter these freshmen are now receiving copies of the U. of I. Housing Contract. The tendency is that they want to be sure of housing and will sign a contract unless urged to do otherwise.

NOW IS THE TIME to do YOUR part to help by immediately sitting down and writing to our Rush Chairman. Let him know the men with whom you are acquainted who have qualifications to become fellow Alpha Chi Rho members and to carry on the fine traditions of our fraternity in years to come.

# A E JENNER NAMED TRIAL COUNSEL IN HARVEY LEE OSWALD INVESTIGATION

Albert E. Jenner '29, well-known Chicago attorney is now in Washington, serving as trial counsel in presenting to the Warren Commission investigating the assassination of the late President John F. Kennedy all facts concerning Oswald that he is able to obtain. The job is estimated to take several months.

Before leaving for Washington in late December, Jenner was quoted in the Chicago Tribune (Dec. 17) as follows:

"Jenner listed the major areas of his inquiry into many phases of Oswald's life as follows: his education, military service including ability as a marksman, study of the Russian language, court martials (Oswald was an ex-marine) and any technical skills he might possess which would be of value to Russians.

"Also to be investigated is where his money came from, reasons for hiring a room in Dallas away from his family, and how he obtained a job in the Dallas school depository. .."
