# Phi Kappa Chapter House Turns 100 Years Old in 2021, and so does the plumbing!

It's been an incredibly busy summer for Brad LaPayne and the board. It is not a glamorous topic but it is an important topic to discuss when the bathroom fixtures on the second-floor start leaking into the kitchen! The cast iron drain pipes had to be replaced after leaks began May 2020. After numerous investigative hours, the cast iron drain lines were replaced, structural and ceiling restored. Then days later, raw sewage backed up into the second-floor shower. The basement concrete floor had to be jackhammered out to facilitate replacing more drain lines. Nonetheless, water is flowing nice in the Alpha Chi Rho house now!

Brad managed the entire process with contractors and continued to show unwavering time commitment to the house and being on-site to oversee repairs and construction concerns as they arose throughout the summer. The board would like to formally thank Brad for his tireless efforts in managing these critical repairs.

#### **Leasing Update**

DKE continues to be model tenants even during a pandemic. Unfortunately their numbers of available live-in students declined to only 12 for Fall semester 2020 due to Parent concerns about the Virus and social distancing needs for housing. Each student is getting their own room to reduce Covid exposure. This reduced AXP's net rental income from a pre-Covid estimate of \$56,500 for Fall Semester, down to approximately \$24,000 for Fall semester.

DKE has recently voiced their commitment to return to lease the house out for Spring semester starting January 15, 2021 with the same 12 guys until May 16, 2021. This should generate approximately \$30,000 in rental income and put us well above break-even costs for the year. A lease has been drafted and sent to DKE for signature.

The board is very satisfied with how DKE has treated the house to-date and we continue to have a constructive relationship with them in anticipation of increased occupancy for Fall 2021-Spring 2022 with the hopeful emergence of a successful vaccine.

#### **Capital Improvement Phase 1**

With confirmation of the Bob Weiss gift coming early summer 2020 the board was not able to implement phase 1 improvements this past summer. Several plumbing issues arose in the 2<sup>nd</sup> floor bathroom that required emergency repairs and oversight to re-route plumbing and retrofit existing lines from the 2<sup>nd</sup> floor bathroom to repair years of blockage and aging pipes. This work was completed in mid August 2020 in time for DKE to occupy the space for Fall Semester 2020.

Our focus now that plumbing issues have been solved is to plan out the phase 1 capital spend for Summer 2020 with the following improvements

- New first floor patio doors 1<sup>st</sup> floor French Doors are 30+ years old and in need of full replacement. This will significantly improve appearance and heating efficiency of the house for future generations
- New Rear Security Door Replacements Rear Kitchen door, rear hallway door, and basement door all need modern security door and hardware upgrades
- 3) Phase 1 improvements to the 3<sup>rd</sup> floor dorm (Insulation, re-orientation of doors on north and south dorm rooms and electrical in the attic to eventually support phase 2 in another year of 3 new rooms in the former dorm area which will increase house capacity and leasing capacity to a more sustainable 20-25 live-in students
- 4) Water Tank replacements Existing water tanks are 30+ years old and it is prudent to pro-actively replace these now instead of later on an emergency basis which is much more expensive and disruptive
- \* Bob Weiss's generous gift will make these needed improvements possible. Initial plan is for these to be done Summer of 2021 with Phase 2 improvements of the additional dorm rooms in summer of 2022

#### PHI KAPPA RECHARTERING UPDATE - NOVEMBER 2020


Since our last update the Rechartering Initiative has been hard at work preparing for the upcoming steps to return the Phi Kappa chapter back to campus. Six months ago, we received approval from the UIUC Board of Fraternity Affairs (BFA) for permission to pursue the RSO registration process at the University of Illinois at Urbana-Champaign in 2021. This was a critical and major achievement.

As we moved into the summer, our team began dealing with the uncertainty of what college life would be like when the fall semester came around. We began working on numerous scenarios to deal with this new campus life and ensure our recruiting effort would have the most impact. We also took these uncertain times to revamp our Rechartering Initiative into a Graduate Brother Board with the goal of uniting and serving all Phi Kappa brothers and creating better communications and a strong network. A lot of exciting things to come!

To that end, in addition to leading the effort on recolonization of the Phi Kappa chapter, we have also committed and aspire to increase engagement amongst our graduate brothers. We will be organizing regular alumni events, virtually for now and hopefully in person in the not too distant future. We will be sending frequent consistent communications together with the Building Association on a quarterly basis and engaging on our social media platforms (Facebook and LinkedIn). And finally, we will continue our search for re-founding fathers and interacting with other active fraternities and sororities to build a support network for our new undergraduate chapter and set them up for success.

- (1) Recruitment of re-founding fathers, fundraising, alumni event(s) including homecoming planning, interviewing and hiring the National Expansion Consultant that will oversee the Chapter's formative year, and negotiating timeline and strategy with IFC will be the initial phase for the return to campus
- (2) Form the Interest Group, transition the Interest Group to a Colony recognized by the National Fraternity, develop the operations playbook for the Chapter, and recruit the initial class(es) of Brothers
- (3) Register as an RSO, transition the Colony to function under its own leadership, with the Expansion Consultant transitioning to an advisory/mentoring role, continue recruitment and Colony operations, petition the National Fraternity for Chapter status and the return of the Charter to Phi Kappa
- (4) Transition the Expansion Consultant off campus and the Phi Kappa Graduate Chapter into the advisory/mentoring role for the Chapter leaders, secure adequate interest in renting the Chapter house to the undergraduate Chapter members, and complete IFC's probationary period
- (5) Move back into 311 E. Armory Ave and continue building on the revitalized Phi Kappa legacy!

Fall 2022/Spring 2023 – Transition the Expansion Consultant off campus and the Phi Kappa Graduate Chapter into the advisory/mentoring role for the Chapter leaders, secure adequate interest in renting the Chapter house to the undergraduate Chapter members, complete IFC's probationary period

**Fall 2023** – Move back into 311 E. Armory Ave and continue building on the revitalized Phi Kappa legacy! **You can help!**
